RULES REGARDING STUDENT DRIVING AND USE OF PARKING FACILITIES:

1. Only students with a valid parking permit are allowed to park on school grounds. Each vehicle driven to school must have a valid parking permit. Permits cost \$10.00 each.
2. Suspension of parking privileges, towing of vehicles, and/or disciplinary action may occur when violations of parking/driving occur.
3. Obey all traffic and parking signs. Park in marked parking spaces only and in the student parking lots/areas.
4. The speed limit for the parking lots is 5 MPH. Do not park in staff parking lots/areas. Do not park in posted handicap parking spaces.
5. Illegally parked vehicles may be ticketed and/or towed at the owners expense. Fines are payable to PWHS.
6. Students are not permitted to go out to their vehicles in the parking lots from 7:30AM – 3:30PM without permission from PWHS Security and/or an Administrator.
7. Students are not to leave campus in their vehicles during the school day unless they have a college class, PA, etc, or have been called out and signed out in the main office and have a pass to leave campus.
8. There will be no loitering in the parking lots before and after school. Students may not sit in their vehicles before, during or after school.
9. Vehicles should be locked at all times. PWHS and Pueblo School District 70 are not responsible for your vehicle or it's contents while parked on the PWHS campus.
10. **SECURTY STAFF AND ADMINISTRATORS MAY THROUGHOUT THE DAY WALK THROUGH PARKING LOTS AND MAY VISUALLY LOOK INTO VEHICLE WINDOWS FOR SAFETY AND SECURITY REASONS.**
11. **STUDENTS VEHICLES MAY BE SUBJECT TO SEARCH IF THERE ARE REASONABLE GROUNDS TO BELIEVE THAT TOBACCO, DRUGS, ALCOHOL, WEAPONS OR OTHER CONTRABAND MIGHT BE PRESENT IN THE VEHICLE AS STATED IN THE PUEBLO SCHOOL DISTRICT 70 POLICIES PERTAINING TO SEARCHES OF VEHICLES.**
11. **STUDENTS VEHICLES MAY BE SUBJECT TO SEARCH IF THE STUDENT IS IN OR AT THE VEHICLE DURING THE SCHOOL DAY WITHOUT PERMISSION FROM SECURITY OR AN ADMINISTRATOR.**
13. **STUDENTS MAY BRING AND/OR OPERATE MOTOR VEHICLES ON THE SCHOOL PREMISES ON THE CONDITION OF CONSENT BY THE STUDENT DRIVER AND REGISTERED OWNER OF THE VEHICLE TO ALLOW SEARCH OF THE VEHICLE WHEN THERE IS REASONABLE SUSPICION THAT THE SEARCH MAY YIELD TOBACCO, DRUGS, ALCOHOL, WEAPONS OR OTHER CONTRABAND THAT VIOLATES PUEBLO SCHOOL DISTRICT 70 POLICES AND PROCEDURES.**
14. Parking permits should be placed on the inside of the front passenger side of the window. Place the permit on the bottom of the passenger side of the front window so it is visible when looking in the front windshield.
